Independent Auditor's Review Report on the Quarterly and Year to Date Unaudited Financial Results of the Company Pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended

TO THE BOARD OF DIRECTORS OF KRITIKA WIRES LIMITED

- 1. We have reviewed the accompanying statement of unaudited financial results of KRITIKA WIRES LIMITED ("the Company"), for the quarter and nine months ended 31st December, 2024 ('the Statement'). The Statement has been prepared by the Company pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations"), we have initialed the Statement for identification purposes.
- 2.
